

Day 1&2: Depart the USA

Once aboard our flight, we can relax, read, watch the in-flight movie and enjoy complimentary meals and beverage service. Once we arrive in Zurich, we'll meet our Tour Manager and then transfer to Lucerne. Later check-in to our first-class hotel, where we'll have a chance to settle in and unpack before enjoying a special Welcome Cocktail.

Day 3: Lucerne

Explore the spectacular sights and cultural delights of Lucerne on a 2-hour morning walking tour with a knowledgeable guide. Stroll the intimate tangle of alleyways in search of impressive monuments like Chapel Bridge (Kapellbrücke) and the ancient Jesuit Church. Gaze at the metropolitan Culture and Congress Center and delve into the rich historical heritage of the city by listening to entertaining commentary from your guide. (B, D)

Day 4: Lake Lucerne - Mt. Pilatus

After an hour-long cruise around the lake, you'll ride up the steepest — and most scenic — cogwheel railway lines in Europe. Stop at the peak of Mt. Pilatus where alpine vistas await. Your tour finishes outside Lucerne, but it's a short and easy journey back to the city via public bus. (B)

Day 5: Lucerne Cruise

Board the ship at lunchtime and embark on a relaxing First Class cruise on Lake Lucerne to Vitznau or Küssnacht and back. Admire the stunning views of the lake and

its surrounding landscape as you sit down to savor a delicious meal on boat. Enjoy the remaining afternoon at leisure. (B)

Day 6: Grindelwald & Interlaken

Today, travel on through countryside dotted with old Swiss Chalets and towns to Grindelwald, a charming winter resort town in the Jungfrau Mountains. Here we can relax, enjoy the scenery, or have lunch. This afternoon, travel through Interlaken, which is located between Lake Brienz and Lake Thun, and lies at the foot of the world famous Eiger, Monch and Jungfrau Peaks. (B)

Day 7: Day at Leisure (Jungfraujoch)

Enjoy a day at leisure, or you have the option to travel to Jungfraujoch — Europe's highest railway station at a dizzying height of 11,333 feet (3,454 meters) — on this 9.5-hour day trip from Lucerne. A scenic coach drive via the Bernese Oberland delivers you to Lauterbrunnen for a cogwheel train ride. You'll wind through the Kleine Scheidegg mountain pass below the foot of





the Eiger North Face. At the Top of Europe, explore the glaciated Ice Palace and enjoy World Heritagelisted views of the soaring Swiss Alps and Aletsch Glacier from the Sphinx Observatory. (B, D)

Day 8: Return to USA

Say goodbye to Switzerland, as we transfer to the airport for our flight home. (B, In-flight meals)



Post-Departure Trip Insurance

All Adelman Discoveries trips have post-departure travel insurance coverage provided within the base program fee. This coverage includes basic medical coverage of the Trip Participant, lost baggage and trip delays from the date of departure to the date of return. This coverage does NOT include any type of trip cancellation coverage. Adelman Discoveries highly recommends that Trip Participants purchase supplemental insurance that covers refunds for trip cancellations. Trip Participant may purchase one of the options described below.

Supplemental Trip Cancellation Insurance (select only ONE option)

Allianz Trip Cancellation Coverage: Basic post-departure insurance coverage is provided within your program. This coverage includes emergency medical coverage, lost baggage and trip delays. Trip Cancellation coverage is NOT included in this package and must be purchased separately. We recommend you purchase additional Trip Cancellation or Cancel Any Time coverage to protect your vacation in the event of unforeseen circumstances that may require you to cancel your trip. Airport departure city is **Detroit**. All Trip Participants are required to have a valid U.S. passport.

Rate: \$5,049 per person double occupancy. Single supplement, add \$600. Fuel surcharges and airport taxes are included. Single supplements are limited. 1 checked bag per person is included in the program for international flights. Passport, tips to guides, additional checked luggage fees, mandatory tourist taxes paid locally at the hotel, visa, credit card payment fees and other items of a personal nature are not included in the price of the Trip. Adelman Discoveries reserves the right to correct errors or omissions and to change any and all fares, fees, taxes, and surcharges. Order of events, flights, hotels, taxes, charges, fees and fuel charges are subject to change. The price of the Trip is subject to supplemental price increases after the date of purchase due to additional charges imposed by a supplier or government for increased fees, fuel surcharges, taxes, fluctuations in foreign exchange markets, or a combination.

Deposits/Payments: A deposit of \$450 per Trip Participant is required to hold your space on the Trip. The final invoice for the Trip will be sent to the email address you provided above. Cancellations/Refunds: Written notice of cancellation by Trip Participant is required and shall be effective upon acknowledgment of receipt by Adelman Discoveries during normal business hours. Refunds for Trips cancelled by Trip Participants will be subject to the following schedule:

Terms and Conditions

Adelman Travel Systems, Inc. d/b/a Adelman Discoveries, a Wisconsin corporation ("AD") is acting only as agent for the airline, cruise line, rail, coach, hotel, restaurant, insurance, and any other third-party supplier connected with the Trip ("Supplier"). As such, AD does not guarantee and shall not be responsible or liable for any injury, loss, damage, claim, or delay arising out of or in connection with any act, omission, neglect, accident, error, or default of any Supplier's employees, Supplier's agents, or any such persons providing services for or on behalf of the Trip Participants. AD shall not be responsible for any cancellation or alteration of the Trip itinerary if such actions become advisable or necessary for safety and well-being of Trip Participants as determined by Suppliers.

All bookings and reservations made by Trip Participant are subject to and governed by the Terms and Conditions imposed by AD and by Suppliers. Trip Participant is solely responsible for reading and understanding the Terms and Conditions of AD and of each Supplier. Initial payment of Trip fee by Trip Participant to AD constitutes Trip Participant's acceptance to these Terms and Conditions. As such, a "Contract" is created by and between Trip Participant and AD when the Trip reservation and payment are accepted by AD. The Contract shall be governed by the laws of the State of Wisconsin. Any dispute between Trip Participant and AD will be subject to the jurisdiction of Milwaukee, WI. In calculating the cost of the Trip, AD has relied on Trip Participant's consent to these Terms and Conditions, and in the absence of this consent, the cost of Trip would have been higher.

AD will make no refund to Trip Participant in the event of delay, cancellation, overbooking, strike, bankruptcy, force majeure or for elements of the Trip not used by Trip Participant. If there is a difference between AD Terms and Conditions and Supplier Terms and Conditions, the higher cost conditions shall apply. AD reserves the right to cancel Trip, change the Trip itinerary, airline, and hotel, or adjust rates whenever, in AD's sole judgement, conditions of such changes warrant; or if AD deems such changes are necessary for the comfort, convenience or safety of Trip Participant. AD reserves the right to decline to accept any person as a Trip Participant, or to require a Trip Participant to withdraw from the Trip at any time who presents a significant risk to the health and safety of themselves or others which cannot be eliminated or reduced to an acceptable level by AD's reasonable accommodation. AD strongly recommends that Trip Participant purchases supplemental trip cancellation, medical and baggage insurance. Such insurance is available for purchase from AD.

Trips with destinations outside of the United States require all Trip Participants to have a valid U.S. passport. Trip Participant is solely responsible for obtaining the required U.S. passport. Trip Participants are responsible for providing passport details at the time of final payment (150 days prior to departure). Any ticketing change fees related to missing or incorrect passport details will be the sole responsibility of the Trip Participant. Trip Participant releases AD from any liability or responsibility of Trip Participant's passport, visa, vaccination requirements, and all safety conditions of Trip destinations. Trip Participant may obtain medical information requirements by calling the U.S. Public Health Service at 301-443-2403; and travel advisory information by calling the U.S. State Department at 202-647-5225.

Trip Participants may be required to prove they have had a negative COVID-19 test or vaccinations as a condition for travel. Social distancing and the wearing of masks may be required according to the local laws of the Trip destination. AD shall not be liable for any illness, damages, or losses caused to Trip Participant in connection with any pandemic or other actions, omissions, conditions outside of AD's control. To protect each Trip Participant, AD will provide the best available information regarding the pandemic-protective policies and practices of the Suppliers involved, but Trip Participant understands, the Supplier(s) may not apply those policies as diligently as the policies suggest.
